______(initial) **All puppies require a \$300 deposit until the age of two weeks. At two weeks deposits are to be increased to \$500 and a subsequent invoice will be emailed to you. If you are reserving a puppy over the age of two weeks old the deposit will be \$500. Deposits may be made in any form of legal tender including personal check, money order, bank wire transfers or via credit card through paypal. Please**

keep in mind any paypal payments will include the 3.5% (USD or 4% Canadian) paypal convenience charge.

_____ (initial) **All deposits are non refundable so please make sure you have thoroughly thought through this decision. Any forfeited deposit may be applied to a future puppy up to 12 months from the date of deposit. Rollover deposits can be applied to a puppy of your choice, behind already placed deposits. In other words, if you have first pick male on a litter and the timing does not work for you, you can roll your deposit to a male/female from a future litter. However if our next planned litter already has 1st pick male reserved (and this is the pick you originally had), you would be able to reserve 2nd pick male or roll your deposit to a planned breeding that does not have 1st pick male reserved. We will not bump an already reserved puppy.**

A puppy is considered reserved upon receipt of this signed agreement and the required deposit.

_____ (initial) **All shipping costs are the responsibility of the buyer. Depending on weather, age of puppy and airline used, prices range from \$200 - \$350. Crates for transportation range from \$30-\$50 and the health certificate necessary for airline transport is \$48. You can anticipate the normal shipping charges for a French Bulldog puppy to be \$280-\$300 all inclusive and for an English Bulldog, 8-10 weeks old, to be \$300-\$330 all inclusive.**

_____ (initial) **Balance in full is due at 7 weeks of age for all puppies being shipped so that we have time to make flight arrangements. This requires a trip to the vet for the health certificate, a trip to the store for the crate, and flight arrangements. We try to accommodate everyone's shipping needs individually but try to ship multiple puppies as often as possible. Full payment is required in certified funds. These methods include postal money orders, bank wire or paypal (add the convenience fee). If you are picking your puppy up in person cash is the only acceptable method of payment. Please do not be offended that we will not accept a personal check or money order at that time. We also will not accept paypal at that time. If you would like to use paypal for the purchase of your puppy and you are picking the puppy up in person, you will need to pay in full at 7 weeks.**

Please fax or mail back your signed copy of this contract along with your deposit. This document ensures your deposit will be credited to the correct puppy. Within 24 hours of receipt of both, the website will be updated to show your puppy as reserved for you. If you do not see it please notify us right away. We look forward to providing you the puppy of your dreams!
